### Eligibility Requirements and Other Terms and Conditions

- Rebates are offered to O&R New York residential, individually metered electric customers, regardless of their energy supplier.
- Rebate applications must be completed in full, signed by the O&R account holder and mailed to O&R address stated on the rebate, together with a legible copy of the paid receipt in its entirety that indicates the equipment manufacturer, Energy Star model number, date of purchase and store name. Failure to complete this application in full may delay or disqualify your rebate. Applications must be postmarked by December 31, 2017. O&R shall not be responsible for lost, late, illegible or misdirected mail. The most current version of the rebate application supersedes all previous versions.
- Eligible room air conditioners must be Energy Star rated and purchased and installed before December 31, 2017, to be eligible. O&R may conduct an on-site survey inspection or phone/mail survey.
- Customer is not eligible to receive financial incentives and/or rebates for the same room air-conditioner from the New York State Energy Research and Development Authority (NYSERDA) and/or another electric or gas utility company.
- If O&R determines that you are eligible for the rebate, please allow six to eight weeks after O&R's receipt of complete documentation and/or inspections for payments of approved rebates. Rebates will be paid by check directly to the O&R account holder.
- Customer agrees and consents to O&R providing customer information, including but not limited to customer name, account number, electric consumption data, and electric energy savings to its third-party evaluation contractor for program evaluation purposes. The evaluation contractor is obligated to O&R to keep the information confidential. This information may also be provided by O&R to the New York State Public Service Commission. This information will be aggregated with information about other O&R customers.
- Customer shall be responsible for all taxes that may be imposed with respect to the rebate offer.
- Eligibility for the appliance rebates shall be determined by O&R, at its sole discretion. O&R has no obligation to notify the customer in the event O&R determines the customer is not eligible for an air conditioner rebate. Applications will be processed on a first-come, first-served basis until funds are depleted.
- O&R reserves the right to limit quantities, and amend or terminate this rebate offer.
